Let me start with an apology. Many of you will remember last year I recommended you see the world's largest fibreglass catfish in Dunnville, the town of my home chapter. Those companions who waited until the Christmas season to take their spouse on a romantic weekend to Dunnville in order to see this architectural triumph should have been warned. On a more serious note, I wish you all a warm welcome on behalf of the Companions of District 7. The fraternal bond displayed here every year is an encouragement to all who take an active roll in the leadership of this very important organization.

GRAND FIRST PRINCIPAL’S ADDRESS

V.Ex.Comp. and M.W.Bro. Ronald Groshaw, Past Grand Master of the Grand Lodge of Ancient Free and Accepted Masons of Canada in the Province of Ontario, Past Grand First Principals of the Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario; members of the Grand Council; Distinguished Guests and my Companions.

Welcome to this our 153rd Annual Grand Chapter Convocation, in the city of St. Catharines at the Quality Hotel Parkway Convention Center.

M.Wor.Bro. Groshaw, we thank you for taking some of your valuable time to visit with Grand Chapter while representing the Grand Master. Please convey to our Grand Master, M.Wor.Bro. Raymond SJ Daniels, our continued allegiance and support on behalf of the Royal Arch Masons of Canada in the Province of Ontario. I would like to personally thank him for the encouragement and support given to Lynette and myself during our travels together.

I extend my appreciation to the Grand Convocation Committee under the direction of R.Ex.Comp. John Richel, member of the Grand Executive, for arranging the details of our

153rd Grand Chapter Convocation program. Our appreciation also extends to the companions of District 5 and District 7, for their assistance and the officers of Orion Chapter No. 195 for supplying the Chapter's furniture this year.

NECROLOGY: From the impressive ceremony of remembrance conducted by R.Ex.Comp. Gordon Sinclair, Assistant Grand Chaplain, we each reflect on our own special memories of Companions who have passed to the Grand Chapter above. My sincere condolences are extended to each family. Let us not forget our brave young Canadian military personnel that have paid the ultimate sacrifice in the defense of freedom. We pray for the many sick and wounded that they may return to their loved ones in good health. Our sympathies are also extended to the Japanese people in their hour of trial and hardship.

FRATERNAL RELATIONS: The Ontario Masonic Leaders under the chairmanship of the Grand Master met several times at the Keele Street Masonic Center and once in conjunction with the International Plowing Match in the Region of Elgin - St. Thomas, last September. Projects and concerns within the various Masonic bodies were shared in an informal atmosphere. Membership and leadership were given priority status.

Invitations were received and accepted from several Grand Convocations in other Jurisdictions. They included the Grand Chapter of Quebec at Montreal in April 2010, the Grand Chapter of Manitoba in April 2010, the Grand Chapter of Nova Scotia in May 2010, and the Grand Chapter of Virginia at Williamsburg in November 2010. My last Grand Chapter Convocation visit was to The State of New York in Albany in March 2011 where I was made an honorary member of Royal Arch Masons State of New York. The 155th Annual Communication of the Grand Lodge of Canada in the Province of Ontario held at the Royal York Hotel in Toronto in July 2010 was one of the highlights of the masonic year with Lynette and I as guests of M.W.Bro. Raymond SJ Daniels and his lady Brenda. Attendance to official visits, anniversaries, and special invitations to several concordant bodies were accepted and attended. I was an Honourary Member of Occident Chapter No. 77 in January 2011. My attendance was recorded at The Grand Court of the Order of the Amaranth May 27th, 2010, in Markham; The Grand Assembly of Royal and Select Masters of Ontario in St. Catharines May 28th, 2010; and The Grand Imperial Conclave and Sovereign Great Priory of Canada in Toronto from August 20th - 22nd, 2010. I also visited with the Supreme Mother Advisor of the International Order of the Rainbow for Girls on October 16th, 2010, at Grimsby. A number of Installations were attended during the year - St. Patrick's No. 145; Oakwood No 233; St. Clair No 75; Headwaters No 83; Port Credit No 230; Tecumseth No 264; King Cyrus No 232 and White Oak No 104 were but a few. Also, several social events were attended where I was able to talk casually with many of the Companions.

CONDITION OF THE ORDER: On October 11, 2010, I journeyed to Havelock to celebrate with them the 100th Anniversary of Ionic Chapter No. 168. At the same time a rededication of the masonic building was performed. I was well received and the evening was a success although there were only a small group of Companions. On November 13, 2010, I again journeyed to District 11 where the Grand Council dedicated the Warkworth Masonic Hall. This is the new meeting place of Warkworth Chapter No. 110. Another highlight was the visit to St. Catharines to witness the installation and the celebration of the 150th anniversary of Mount Moriah Chapter No. 19 in District 7.

Many Chapters have exhibited improvement in the quality of work and must be commended for the positive efforts shown. In general, evidence of new applications is related to those Chapters who vigorously promote Royal Arch Masonry. Unfortunately, there are a few of the Chapters that need growth and stability. In October 2010, the Grand Third Principal, R.Ex.Comp. Brian Van Sickle, on my direction as the Grand First Principal, removed the Charter of Temiskaming Chapter No. 169 after visiting the Chapter and recognizing some problems.

The Grand First Principal then ordered the First Principal of Temiskaming Chapter No. 169 to attend Grand Chapter and discuss the removal of the Charter and other issues facing the membership and attendance in District 14. Items of concerns were discussed regarding the multiple common memberships in three Chapters in District 14. V.Ex.Comp. Bill Praskey returned to Temiskaming Chapter No. 169 under certain guidelines.

Some Chapters experiencing internal conflicts through possible power struggles are not conducive to a positive and healthy environment thereby disturbing the harmony of the Chapter.

TRUSTEESHIP: Efforts were made to improve and help the Chapters under trusteeship. A number of these Chapters failed to reach a quorum at least once during the masonic year. I have decided to retain R.Ex.Comp. Dan Knox as the trustee for Manitou Chapter No. 27 District 4; and appoint Ex.Comp. Clive Stephenson as trustee for Temiskaming Chapter No. 169 District 14. These Chapters have not reached a satisfactory level to operate as a Chapter and assistance is still recommended. A number of the Chapters show the need for concern by Grand Chapter. They are encouraged to seek assistance to strengthen masonic membership or to amalgamate with another Chapter. The future depends on a positive commitment by all chapters' members to design a suitable plan and with the help of the Trustee to put it into action.

AMALGAMATIONS: The new amalgamated chapter of Prince of Wales No. 133 continues to meet in Perth. Appreciation goes to R.Ex.Comp. Roderick Haufe for his role and patience as representative to the Grand First Principal in the amalgamation process.

PAST RANK: I was fortunate to install and invest Ex.Comp. Gordon J.J. Simmons as a Past Principal of Hiawatha Chapter No. 252 in District 1 on Monday, February 7, 2011. It gives me great pleasure to recommend the conferral of the rank of Past First Principal to Comp. Gary Dowling the current Deputy Grand Master and a companion of St. John's and St. George's Chapter No. 3, as per Section 26(w)(i) of the Constitution of Grand Chapter. In addition I recommend that R.Ex.Comp. J. William Lidstone be made an Honourary Member of the Grand Executive Committee for his long standing service to this Grand Jurisdiction.

ANNUAL RETURNS: During the past several years we have tried to relax that portion of the Constitution which deals with annual returns.

The forms are readily available on the web site and from the Grand Chapter office. There were still eleven Chapters not properly returned as of the deadline date of January 31, 2011. Under my direction, letters, with copies to the District Grand Superintendents, were sent by the Grand Scribe Ezra to the First Principals of those Chapters listing the

consequences should their written explanation and Annual Returns not be submitted prior to February 28, 2011. As of March 1, 2011, there were still two Chapters, Aylmer No. 81 and Toronto Antiquity No. 91, not properly returned. They were individually advised on March 4th and copied to the Grand Superintendent, that in accordance to Section 20(q); "The current presiding officers (First, Second, Third Principals and Proxy) are deprived of the privileges of voting at this Annual Convocation of Grand Chapter. This clause shall not deprive a Past Principal, in possession of a current dues card, of his vote as such:". This is much better than previous years but it would however, be preferred to have all Chapters returned with all Principals allowed to vote.

ROYAL ARCH CHARITIES: The Medical Research Million Dollar Club is still active and the keystone with a certificate will remind you of your generosity. Are you a member yet? If not, see the chairman and join the club. For this charity, a number of raffle tickets were prepared, widely distributed and sold throughout the year. Approximately \$5,000.00 was raised for this event. The draw and prizes will take place at this Convocation. The tickets will give you a chance to win free accommodation and supper at the 2011 Convocation or another time at the winner's discretion and other prizes as well.

Companions are encouraged to join the Million Dollar Club as this will help raise the Capital fund to the ultimate goal of One Million Dollars. It will allow Grand Chapter to more easily distribute the yearly disbursements to medical research teams. Promotional brochures are available for information on the support of medical research programs. Thanks to the Districts Charity projects, your donations have been applied to the intended charity in order to make our usual contributions. Grand Chapter thanks Mrs. Joan Emmett for the generous donation given in memory of M.Ex.Comp. Charles Emmett, Past Grand First Principal, and this donation has been added to the Release a Miracle Fund.

Student Bursary awards are equally important to assist our young students facing the rising cost of education and the unemployment rate affecting job opportunities. Remember your Royal Arch Charities, use the self addressed Royal Arch Charities envelope for contributions as well as regular donations.

PUBLIC RELATIONS: Under the chairmanship of R.Ex.Comp. Alan Donovan a new promotional information project was presented. The new Royal Arch DVD is finished, and is being distributed. The new pamphlets are printed and are designed to complement the DVD and the Public Relations web site. The Royal Arch booth at The Grand Lodge Communication last year was the launch of the new look in Royal Arch promotional material. The booth featured a flat screen TV showing the DVD, and a digital picture frame showing fifty pictures. The Public Relations Committee had a busy summer and the Public Relations web site was launched in November. Companions however, can assist in promoting Royal Arch Masonry at the Lodge level by ensuring that the DVD and pamphlets are available in their building. I thank R.Ex.Comp. Alan Donovan and his committee for their yeoman service during this past year.

MANUALS: The Grand Lecturer, R.Ex.Comp. Des Washer, has completed and edited the Manual of Etiquette and Protocol to eliminate some items creating confusion and will soon be printed for distribution. Current forms are available on the Royal Arch website and the instruction for the Scribe Ezra manuals is updated as guidelines for instruction. Remember to make use of all approved updated Manuals to aid in the operation of your Chapter, and instruction to officers.

CONSTITUTION: To the Chairman of Laws and Jurisprudence, R.Ex.Comp. J. William Lidstone, thank you for your dedication to the supervision of our Constitution and processing of By-law Amendments.

This was an attractive offer for a central location for restaurants and shopping with easy access just off the 401. A four year contract has been signed and details are now in the planning stage.

APPRECIATION: To R.Ex.Comp. Michael Bowman, Grand Second Principal; R.Ex.Comp. Brian Van Sickel, Grand Third Principal; I thank you for your friendship and hard work over the past year. It makes my journey a more pleasant experience. I wish you well in your future endeavors and will be looking forward for your help and support during the next year. M.Ex.Comp. Richard J. Jackson, Grand Scribe Ezra, without your

guidance and support the office would not be functioning at its present high standard. I am looking forward to a pleasant and smooth journey this masonic year. I personally express my appreciation for the assistance and friendship developed over the past six years. To the Officers, Chairmen and Members of the Grand Executive Committees and Ad Hoc Committees, your dedicated contribution to the various committees is the backbone of the executive. Thank you for allowing me to have a successful year. To the standing committees of Grand Chapter, keeping the business of Grand Chapter in line is the key to a successful fraternity. Thank you for your commitment.

To the Most Excellent the Grand First Principal, Officers and Members of the Grand

Most Excellent Sir and Companions:

I am pleased as Chairman of this Committee to present the Committee Report for the year 2010-2011 covering administration under its mandate during the above period, together with other matters dealt with by the Committee as required by the Constitution of Grand Chapter under Article 59.

NOTICES OF MOTION:

I, R.Ex.Comp. Charles W. Crow, hereby give notice that at the next Annual Convocation of Grand Chapter, I will move or cause to be moved the following amendment to the Constitution:

That Section 29 (k) be deleted and replaced with “ Prior to the 15th day of May following the Annual Convocation of Grand Chapter, he must prepare a detailed letter addressed to the attention of the First Principal of each Chapter in his District to be read in open Chapter, detailing all changes to the Constitution and other rulings resolved at the latest Grand Chapter Convocation. The First Principal will confirm in writing to the Grand Superintendent receipt and compliance to this letter.”

Subsection(m) be deleted and replaced with “ He shall arrange for holding a Chapter of Instruction pertaining to the Work and Administration of the Chapters in his District and Report to the Grand First Principal that this duty has been performed.”

Your Committee finds this amendment to be regular and in order.

I, V.Ex.Comp. Dennis C. Hill, hereby give notice that at the next Annual Convocation of Grand Chapter, I will move or cause to be moved the following Amendment to the Constitution:

That Section 18(a) be deleted and replaced with: “Only those who are a Past First Principal as of Four p.m. on November Thirtieth prior to the Grand Chapter Convocation at which the voting is to take place and who reside within this jurisdiction are eligible for any office in this Grand Chapter except for, and granting of, a dispensation under section, DUTIES, POWER AND RULES REGARDING THE GRAND FIRST PRINCIPAL. Everyone elected or appointed to office in the Grand Chapter must, during his term of office, be a subscribing honorary or life member of a Constituent Chapter duly returned.”

Your Committee finds this amendment to be regular and in order.

I. M.Ex.Comp. Richard J. Jackson, Member of the Finance Committee, hereby give notice that at the next Annual Convocation of Grand Chapter I will move or cause to be moved the following Amendment to the Constitution.

Section 71, Subsection (c), delete the last paragraph and replace with “For every member of the Chapter on the register of Grand Chapter as at the previous December Thirty First, payable semi-annually on the Thirtieth of June and the Thirty First of December each year effective April 30, 2011 - \$8.50

Your Committee finds this amendment to be regular and in order.

Since last reporting to the Grand First Principal and the Companions of Grand Chapter in 2010, your Committee has dealt with Five (5) issues brought to their attention pertaining to interpretations as per our mandate under the Constitution.

In addition Fourteen (14) submissions from Constituent Chapters pertaining to amend their By-laws, have been received reviewed and recommendations made to the Grand First Principal for either approval, minor changes before receiving his approval, or not recommended for approval.

The Grand First Principal in his address to this Grand Convocation in 2010 recommended that the Committee on Constitution, Laws and Jurisprudence examine and review the matter of and we quote **“soliciting a selected nominee for any office on the ballot papers prior to the election”** The Constitution under Section 18 NOMINATION OF OFFICERS is quite clear as to the restrictions imposed on both candidates and others “prior to the issuance of the list of nominations for the various offices from the Grand Chapter Office”. Under Section 79 CHAPTER SUMMONS (c) No reference to any Royal Arch Mason seeking elective office will be made in a summons. These are the only restrictions in the Constitution 2010.

In the 2010 Report of the Committee on the Grand First Principals Address is the following pertaining to the Grand First Principals recommendation “this committee supports this recommendation and would hope that the Constitution Laws and Jurisprudence committee will call upon the experience, beliefs and suggestions of our Past Grand First Principals and other knowledgeable Companions in developing a policy...”

No consensus has been arrived at pertaining to such a proposed amendment, or the need for one and therefore, no amendment to the Constitution has been purposed or prepared.

REPORT OF THE BURSARY COMMITTEE

To the Most Excellent, The Grand First Principal, Officers, and Companions of the Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario.

Most Excellent Sir and Companions:

On behalf of the committee, I would like to thank you for the honour of serving this Grand Chapter. This year we have processed 68 applications, 65 were approved and 3 rejected. The total amount awarded was \$20,350, well within the budget of \$25,000. Of the 65 awards 35 were first year applicants; 19 second year and 11 third and fourth year. There were 22 male applicants and 43 female.

The committee has encouraged the practice of presenting the awards in chapter, with the student and family members present wherever possible. We feel this promotes our craft

and could possibly lead to new members in the future.

The applications received were from a varied area from around the province with 14 of the 15 districts represented.

The current system of processing the applications is working well and we see no reason at this time to modify the format. The newer forms are being used more frequently and we would once again ask the Grand Superintendents and Scribe Ezra's to keep their supplies up to date. The forms are also available for download from the Grand Chapter website.

Currently the amounts awarded are \$250 - first year; \$350 - second year; \$450 for third and fourth year. These amounts have been in place for sometime, and the trend over the last few years have been within the budget.

After reviewing the previous records the committee therefore recommend that the fourth year award be increased from \$450 to \$500. We feel that this would not have a significant impact on the funds available and would afford a little more assistance to the well deserving students whose expenses seem to rise constantly year after year.

REPORT OF THE FRATERNAL CORRESPONDENCE COMMITTEE

To the Most Excellent the Grand First Principal, Officers and Members of The Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario.

Most Excellent Sir and Companions:

As Chairman of the Fraternal Correspondence Committee I had the opportunity and pleasure of receiving and reviewing the Annual Proceedings of the following Grand Chapters: District of Columbia, England, Greece, Indiana, Iowa, Ireland, North Carolina, North Dakota, Ohio, Pennsylvania, Scotland, South Australia and Northern Territory and Vermont a total of 13 jurisdictions. Seven of these jurisdictions used a CD format. Some jurisdictions have their proceedings available on their website to be downloaded and read.

The Grand Chapter of Greece prides itself in visitations to several jurisdictions such as Estonia, Ireland, Netherlands, Germany, Hungary, Italy and Scotland. The visit I found interesting was their visit to Hungary where the establishment of the Symbolic Grand Chapter of Hungary has been formed by two Chapters in the jurisdiction of the Supreme Grand Chapter of England and one Chapter in the jurisdiction of British Royal Arch Masons in Germany.

In the District of Columbia they have an annual multi-jurisdictional festival. It was held in the George Washington Masonic Memorial and 32 candidates received their degrees.

In Indiana the Grand Chapter encourages goal setting and planning by the local chapters

which is important to the welfare and health of the local Chapters. Chapters should set realistic and measurable membership and retention goals; and to create and implement simple and specific one, three and five year plans for the future growth and health of their Chapters.

In Iowa the York Rite Bodies are selling themselves to prospective candidates for what they are - further light in Masonry; the completion of the story that started in the Blue Lodge. For them "It is working!" Candidates now join Chapters for reasons other than "I want to join the Shrine". It brings to mind what I've personally said to prospective candidates. I remind them that in the Master Mason degree the genuine secrets were lost, in Chapter these are found. I'm hoping this will entice them to want to join.

In North Carolina they hold the Grand York Rite Masonic Bodies of North Carolina, a joint convention which includes Royal Arch Masonry, Royal and Select Masters and Commandery. Many local bodies combine resources when hosting a York Rite Festival. This combination of resources takes place when two or more local bodies divide degree work by assigning combinations of Companions and Sir Knights to work on a degree as a joint project, or assigning one body half or one third of the Chapter, Council and Commandery degrees and similarly assigning degrees to the other local bodies. In this manner two or three bodies are able to pool resources and manpower to make their festivals a success. This year their Membership Committee distributed many of their programs along with the membership DVD to members interested in the development of new members.

In Ohio they invited every one of the Ohio Grand Representatives to take part in the Report of Fraternal Correspondence. They found this has been a change for the good. They found that it has created an excitement that has stimulated more of their Grand Representatives to travel to their Counterpart Jurisdiction for their Grand Convocation. They have achieved a "break through" in starting dialogue with the other Grand Jurisdiction.

In Vermont they are proposing that a single Membership Committee be formed to cover all three bodies: Chapter, Council and Commandery. The makeup of this committee would include at least one member from each of these bodies. In addition, since part of the mission of their York Rite College is to "promote York Rite Freemasonry and cooperation between the Bodies," they suggest that a member from York Rite College be appointed to this committee as well.

They believe that membership should be seen more broadly, not just petitioning new candidates. In that regard, it is suggested that each chapter should follow some sort of organized membership program. A 3-tiered example is outlined below:

1. Obtaining the prospects - This part is the most familiar and emphasizes contact with Blue Lodges in the form of presentations and encourages the chapter to identify York Rite Ambassadors within each Blue Lodge who could serve as the liaison to that Lodge. An informational packet should include items such as (a) cover letter (b) sample magazine (c) newsletter (d) petition and (e) website info etc.
2. Sustaining the candidates - This aspect emphasizes mentoring the candidates and is an extremely important but often forgotten component of membership. At this stage the

chapter should maintain a candidate list; keep close communication with the candidates; emphasize education, proficiency, etc. Candidates can be given further information such as (a) schedule of degrees (b) overview of York Rite in Vermont (c) York Rite history, etc.

3. Maintaining the members - Here the emphasis is not only on continuing to mentor the new Companions after they have completed their degrees, but also making the chapter itself exciting and alive since ultimately this helps to keep all members interested, not just new ones! This, by itself, has the potential to attract new candidates! More detailed information should be made available such as (a) officers (b) committees (c) other specifics about the Chapter/Council/Commandery that will help them become more involved.

In South Australia and Northern Territory they have organized "Education Days" which are intended to assist members to understand and better appreciate the beauties and teaching of our Order. They also have developed a "booklet" for new members.

Many jurisdictions still promote the use of technology that include websites, down loadable brochures, CD format proceedings, emailing information, communications through newsletters on the internet, annual proceedings that can be down loaded in PDF format.

I would like to thank you, Most Excellent Sir, for the opportunity to serve our Grand Chapter these past two years. I found this committee a very interesting and rewarding experience. I would like to thank our Grand Scribe Ezra for his continuing support.

REPORT OF THE INVESTMENT COMMITTEE

To the Most Excellent the Grand First Principal, Officers and Members of The Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario.

Most Excellent Sir and Companions:

Your investment committee is responsible for monitoring the management of our three portfolios: the General Account, the Scholarship and Bursary Account, and the Medical Research Account. These three portfolios are managed by RBC Dominion Securities, within the investment policy guidelines approved by the Grand Executive Committee of

The Grand Chapter. These guidelines provide for the allocation of assets including cash, short-term investments, fixed income investments, and equities within the three portfolios. Your investment committee is in regular contact with our financial advisor, meeting with him in person and receiving regular reports both by mail and electronically.

These objectives of The Grand Chapter investment policy are to achieve long-term capital and income growth consistent with low to moderate risk, while producing an income stream to provide for operating expenses, and the funding of Scholarships and Bursaries and Medical Research. In order to balance these objectives, our policy has been to limit the proportion of equities in our portfolios to no more than 30% of the total.

The fiscal year March 1, 2010 to February 28, 2011 was a time of continued recovery and growth for Canadian equities. Our portfolios have participated in this growth, but to a lessened extent because of our policy limiting our exposure to equities. Even with this limited exposure to equities, our three portfolios have grown by amounts between 7% and 10%. As predicted at this time last year, this policy has not only provided our investments with downside protection during the bear market, but has allowed us to reap the benefit of the market recovery, or bull market. In addition, by limiting our equity investments to large-cap, blue chip, Canadian investments, we have avoided currency risk, and have avoided markets in Europe and the U.S.A. that have not enjoyed the same degree of recovery as those in Canada.

The balances and year to year change of our three portfolios are as follows:

We believe that our portfolios are well positioned not only to benefit from the market growth that is anticipated to continue, but to provide protection in the event of any unexpected downturns in the market. We also believe that our portfolios will benefit from anticipated increases in interest rates.

Finally, the members of the Investment Committee R.Ex.Comp. David R. Pass, M.Ex.Comp. Richard J. Jackson and R.Ex.Comp. Shavak R. Madon, thank you for having given this opportunity to serve our Grand Chapter.

REPORT OF THE GRAND TREASURER

To the Most Excellent the Grand First Principal, Officers and members of the Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario.

Most Excellent Sir and Companions:

Once again it is my privilege to present to you the financial statements of the Grand Chapter, the Medical Research Fund and the Scholarship and Bursary Funds for the year ended February 28, 2011.

The following are the highlights for the fiscal year 2011:

The Grand Chapter: The total revenue was \$138,844 compared to \$135,543 in 2010. Our revenue reflects unrealized investment gain of \$22,025 compared to \$21,156 in the prior year. Our expenses amounted to \$100,362 as against \$105,075 in the prior year. We ended the year with excess of revenue over expenses of \$38,482 compared to \$30,468 in the prior year.

The Scholarship and Bursary Fund: We paid out bursaries of \$20,350 compared to \$25,700 in 2010. We ended the year with a surplus of \$39,841 compared to \$48,005 in the prior year. Again the surplus was a result of unrealized investment gain of \$43,082 compared to \$36,041 in the prior year.

The Medical Research Fund: During the year we made grants of \$25,000, the same as \$25,000 in the prior year. We ended the year with a surplus of \$36,414 compared to \$45,443 in the prior year. Our donations were \$17,408 compared to \$12,865 in the prior year. The unrealized investment gain amounted to \$32,5031 compared to \$18,320 in the prior year.

Investments: The market value of our total investments at the Grand Chapter, the Scholarship & Bursary Fund and the Medical Research Fund amounted to \$1,959,398 compared to \$1,843,343 in the prior year.

General: As in prior years, I met several times with the Grand Scribe Ezra to discuss the financial affairs of Grand Chapter. I sincerely appreciate the efforts of our Grand Council and Grand Scribe Ezra to stringently control the finances of the Grand Chapter and the two related funds. I would like to thank the Grand Scribe Ezra for the fullest cooperation provided to me throughout the year.

Finally, I would like to acknowledge the efforts and dedication of the Finance Committee and Investment Committee members.

REPORT OF THE FINANCE COMMITTEE

To the Most Excellent the Grand First Principal and Members of The Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario.

Most Excellent Sir and Companions:

The audits for the year ended February 28th, 2011, have been completed. Once again no recognition has been given to any realized and unrealized capital gain or loss on the sale of investments in the budgeted figures. This is of course recognized in the audited financial statements.

Our actual revenue for 2011 totalled \$138,844 compared to the budget of \$102,100. Our expenses were \$100,362 against a budget of \$111,600. As a result we have a net surplus of \$38,482 compared to a budgeted deficit of \$9,500, which figure does not include unrealized capital gains.

For the fiscal year ending February 2012 we are projecting a budgeted income of \$107,600 compared to budgeted expenses of \$118,800 resulting in a budgeted deficit of \$11,200. Our main increase in expenses is in Public Relations to purchase new displays in each District either by stand-up boards, or by digital programs. Also, a new separate website has been established for Public Relations. Our revenue from membership will remain fairly constant, therefore, we are projecting per-capita dues of \$88,000, based on a reduction of \$2,000 from loss of membership, plus an additional \$5,000 from the increase in dues, which are subject to approval at the Grand Convocation.

Our revenue in 2011 for the Scholarship and Bursary Fund recorded a total of \$61,745, less expenses of \$21,904, for a surplus of \$39,841. In 2010 we had a surplus of \$48,005.

Our revenue in 2011 from the Medical Research Fund totalled \$63,694, less expenses of \$27,280, for a surplus of \$36,414. In 2010 we had a surplus of \$45,443.

I am pleased to report that we continue to have a good relationship with our auditors Lepore & Company, Chartered Accountants.

letter addressed to the attention of the First Principal of each Chapter in his District to be read in open Chapter, detailing all changes to the Constitution and other rulings resolved at the last Grand Chapter Convocation. The First Principal will confirm in writing to the Grand Superintendent receipt and compliance to this letter. The Grand Superintendent will then advise the Grand First Principal that his duty has been performed.”

Subsection(m) delete and replace with “He shall arrange for holding a Chapter of Instruction pertaining to the Work and Administration of the Chapters in his District and report to the Grand First Principal that this duty has been performed.”

I, V.Ex.Comp. Dennis C Hill, hereby move the following amendment to the Constitution: Subsection 18(a) be deleted and replaced with “Only those who are a Past First Principal as at Four p.m. on November Thirtieth prior to the Grand Chapter Convocation at which the voting is to take place and who reside within this jurisdiction are eligible for any office of this Grand Chapter except by request for; and granting of, a dispensation under section **DUTIES, POWER AND RULES REGARDING THE GRAND FIRST PRINCIPAL.** Everyone elected or appointed to office in the Grand Chapter must during his term of office, be a subscribing, honorary or life member of a Constituent Chapter duly returned.”

Most Excellent Sir and Companions:

The membership as of December 31, 2010, is reported to be 6759, indicating a continuing decline through 2010. The loss of members still exceeds membership gain by a factor of 2. Deaths were equal to Advancements but Suspensions and Demits far exceed the Affiliations and Reinstatements. There are 99 Chapters at the end of 2010.

Four Chapters will celebrate their 150th Anniversary, one will celebrate its 125th, and one will celebrate its 50th Anniversary in 2011. It is hoped that celebrations will mark these milestones and the Grand Historian can be contacted to assist with any celebration plans.

A project was initiated last year to acquire a copy of all existing written histories of Chapters within this jurisdiction. This project will continue with the hope that there are some in existence. A second project is in progress to update the existing Grand Chapter Histories which will include identifying the grave sites of the Grand First Principals.

REPORT OF THE COMMITTEE ON THE MEDICAL RESEARCH FUND RELEASE A MIRACLE

Most Excellent Sir and Companions:

This report covers the activities of the Committee on Medical Research of The Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario for the year ending February 2011.

As you are aware, the immediate goal of the Medical Research Committee is to establish a capital investment fund of One Million Dollars for investment purposes to keep the fund ongoing through the generosity of all companions of Royal Arch Masonry in the Province of Ontario by their:

- (a) Personal donations
- (b) Bequests by the companions who have made a provision in their estate planning
- (c) Support of the Million Dollar Club

For contributions to the Medical Research Fund, which qualifies as a charitable trust under the Income Tax (Canada) Act, for which relative tax receipts will be issued.

The year's labours started off at the 152nd Grand Convocation with the Raffle 2010/11 set in motion having the following prizes:

- 1st Prize - Two nights accommodation and lunch for two at the Quality Hotel Parkway Convention Centre
- 2nd Prize - Handmade afghan
- 3rd Prize - Signed print by Alyson Robichaud
- 4th Prize - Dirt Devil vacuum cleaner
- 5th Prize - A four led light electrical fixture

Ticket price was 3 for \$5.00 with draw to take place at The Grand First Principal's Banquet at the 153rd Grand Convocation.

Raffle outline with tickets was mailed to the Grand Council, Grand Superintendents and all Chapters under the jurisdiction of the Province of Ontario. Returns to March 15, 2011 are \$4,097 with expenses of \$294.67 and although this was a great deal of work and the returns are gratefully acknowledged, the Medical Research Committee decided at the Fall 2010 Grand Executive meeting to go to the companions with a new raffle in 2011/12 with the Grand Prize donated by Via Rail Canada of a return railway pass for FOUR persons for travel between Aldershot, ON and Quebec City, with a value of \$1,770 and an expiry date of March 2013. A second prize of a three seater fabric covered glider swing has also been donated. The raffle will start at the close of this Grand Convocation with the draw to be held at the 154th Grand Convocation in April 2012 with a ticket price of \$10.00 each or 3 for \$25.00.

The Million Dollar Club began in 2006 and is still growing with each companion member who donates \$100 receiving a membership certificate, an exclusive lapel pin and an income tax receipt. With 211 members to date and 5,500 companions on the Grand Chapter rolls, we have a great potential to make this club grow. This is the year for you to JOIN and IF NOT, WHY NOT???

This year, as last year \$25,000 has been donated to the following Medical Research Projects as recommended by your committee. Autism, Prostate Cancer, Arthritis and Alzheimers research centres are the recipients of \$6,250 each as follows:

- a) Dr. Jeanette J.A. Holden, Director, Autistic Spectrum Disorders, Queen's University for research into the genetics and epidemiology.
- b) Dr. Neil Fleshner, Head Division of Urology, University Health Network for investigations into the relationship of dietary factors to prostate cancer.
- c) Dr. Edward Keystone, Director, Centre for Advanced Therapeutics in Arthritis AARC Foundation, University Health Network conducting research on new treatment modalities.
- d) Professor Peter St. George Hyslop, Director, Centre for Neurodegenerative diseases University of Toronto. Advance studies of gene effects of Alzheimers.

With 2010 behind us, your committee is looking forward to 2011. With the Canadian economy recovering, we beseech All Companions to support your Grand Chapter Medical Research Committee through your charity in helping to reach the One Million Dollar Capital Investment Fund, which as of February 2011, has \$691,663.60 in funds for Release-A-Miracle research projects.

REPORT OF THE COMMITTEE ON THE CONDITION OF CAPITULAR MASONRY

To the Most Excellent the Grand First Principal, Officers and Members of The Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario.

Most Excellent Sir and Companions:

The final report from the Grand Superintendents were for the most part completed on time; their honesty and integrity in reporting has contributed to these recommendations for Royal Arch Masonry in Ontario.

Official Visits

Grand Superintendent Reports indicate that official visits went well overall, proper protocol is being observed. We recommend that the incoming Superintendents request the First Principals in their respected District familiarize themselves with the book of Protocol and Etiquette thus eliminating any last minute anxiety. Some of our Grand Superintendents were required to overcome great difficulty in last minute cancellations of official visits. Therefore, requiring the necessity of establishing a second visit. One Grand Superintendent was still unable to accomplish this and therefore summoned two Chapters to produce to him the books and registers enabling him to complete the requirement of his office. The Chapters are reminded that they must confer or exemplify a degree at official visits. The word exemplify has been brought into question this year, some think it means bit parts. The Encyclopaedia of Freemasonry describes Exemplification of the Work as and I quote "When a lecturer or teacher performs the ceremonies of a degree, using generally one of the Masons present as a substitute for the candidate. It is done for instruction, or to enable the members of the Grand or subordinate Lodge/Chapter to determine on the character of the ritual by the exemplifier." Winston's dictionary states: to make a legally certified copy of.

I trust this quantifies exemplify.

We commend the Chapters for the dignity shown by them to the Grand Superintendents.

Course of Instruction

You have before you today a recommendation to amend the Constitution from the Committee on the Condition of Capitular Masonry. I therefore hesitate to report on this matter and leave it to your discretion to make a prudent decision.

Membership

Our numbers seem to be holding steady. We can say that in all honesty. Chapters that have taken the initiative to bring Royal Arch Masonic education to Craft Lodges, with the permission of the Master of the Lodge. By calling off and having a delegation of Royal Arch Masons in Regalia make a presentation are having more success than simply Master Mason nights. It seems to have taken us a long time to figure this out....if the mountain will not come to Mohammed, Mohammed will go to the mountain.

Many chapters are becoming very inventive in their recruitment. One, even inviting limited numbers of Master Masons to a special free festive board. Then, inviting other chapters to partake with them, enabling all, to share in prospective new members. We are pleased to recognize these innovations.

I look forward with great pleasure to when one can report our new membership is outpacing any and all expectations. Any and all initiatives that are found to be yielding results should be forwarded to the Public Relations chair.

The Work

Here again some Chapters are performing excellent work while others have open books. We encourage a walkthrough of degrees and the reading aloud of each portion of ritual including lectures, mechanics and italics portions. In doing this it will enable members and officers to brush up on and keep fresh in their minds the floor work and mechanics of each degree. Encourage the newest member to take an active part in the Work no matter how small. May the recollection of the first instance you were asked to perform ritual in a chapter be the motivation to develop these companions into our replacements. That's sustainability.

Duties and Responsibilities

I hesitate to bring this to the attention of this Grand Convocation. I will however not negate the duties of Chair of the Committee and we make the following recommendation. The temperance and fortitude of not only Grand Superintendents but of your Grand Council has been challenged this year, by certain acts, ways and means that are uncharacteristic for any Mason, but more particularly a Royal Arch Mason.

We have all taken oaths and obligations in respect to the performance of our duties. Not only to uphold and maintain the Constitution, but to live within basic fundamental Masonic principals. This year some personnel interests seem to have been allowed to take precedence over the established majority which has ratified the written laws and regulations of our Grand Jurisdiction. While others have taken brotherly love or treating everybody as we wish to be treated, not just when it suits us but all of the time. Easy to say difficult to do. Relief and/or charity, too often thought of as monetary assistance over the more demanding part, being the simple act of forgiveness and turned them into petty piques and quarrels disrupting the peace and harmony of not only the chapters but the growth of bonds of friendship that more closely unite us all. These things should not exist between men of good will and honour as all Royal Arch Masons are. Let us not forget the obligations we have solemnly and sincerely taken upon ourselves and more importantly ever remembering those duties and responsibilities we have sworn to each other.

Finally, I would like to thank the 15 Grand Superintendents and their Secretaries for their work and dedication. Any job worth doing does not come without challenges; you have met them head on and faithfully fulfilled your duties. May your memories be those of joy and humility with respect to the honour your companions have bestowed upon you. To the new committee members, Grand Superintendents elect, officers and companions all, my final recommendation to you is to bring Light to all uninformed Masons "Light is Knowledge".

As previously stated the main objective of the Public Relations Committee is to raise the profile of Capitular Masonry, and it is the opinion of the committee that this mandate has been met. The DVD "Fervency and Zeal" has been produced and distributed also, the brochures and lapel pins. In addition the Public Relations website is up and running. The committee is currently revamping the Royal Arch website, and should be finished soon. The hits on the website continue to grow which I think is a sign that masons are still interested in Capitular Masonry.

In order to simplify the distribution of all promotional materials, a system of distribution has been put in place where every Public Relations Committee member has one or two districts to look after. **REPORT OF THE COMMITTEE
ON THE GRAND FIRST PRINCIPAL'S ADDRESS**

To the Most Excellent the Grand First Principal, Officers and Members of the Grand Chapter of Royal Arch Masons of Canada in the Province of Ontario:

Most Excellent Sir and Companions:

Your Committee on the Grand First Principal's Address to this our 153rd Convocation, has had the opportunity to review that Address.

Your Committee joins with the Grand First Principal and all members of Grand Chapter at this Convocation in welcoming V.Ex.Comp. And M.W.Bro. Ronald Groshaw, Past Grand Master of the Grand Lodge of Ancient Free and Accepted Masons of Canada in the Province of Ontario, who is representing the Grand Master, M.W.Bro. Raymond S. J. Daniels.

Your Committee notes the Grand First Principals comments on the leadership of the Grand Master as Chairman of the Ontario Masonic Leaders meetings in an informal atmosphere, where Membership and Leadership were given priority status.

In his comments under Condition of the Order, we note that many Chapters have exhibited improvement in the quality of their Ritual. However, two Chapters have had many problems over the past several years and these problems have been noted by Past Grand First Principals I n their Grand Convocation addresses. We hope that the temporary removal of the Charter of one of those Chapters, and the subsequent return of the Charter under trusteeship will serve to bring internal harmony into that Chapter. The second Chapter that continues under trusteeship had had internal problems over many years. His comment that "We must not allow external piques and quarrels to drift into the Chapter" identifies problems in several other Chapters as well.

He noted the new amalgamated Prince of Wales Chapter No 113 continues to meet in Perth, and expressed his appreciation to R.Ex.Comp. Haufe for his role in the amalgamation process.

The Grand First Principal has recommended both Past Rank and Honourary Membership in the Grand Executive Committee.

Under ANNUAL RETURNS, the Grand First Principal noted that during the past two years, Grand Chapter has tried to relax that portion of the Constitution which deals with Annual Returns. We are sorry to learn that two Chapters were still not properly returned as of March 1st, 2011.

The Grand First Principal has reminded us of our Royal Arch Charities and the need to support the important research it funds; as well as the Student Bursary funds. He noted that the Million Dollar Club is in fact a Capital Fund, and urged all Companions to support the fund to reach the goal of One Million Dollars, to continue funding medical research. He also reported on a generous donation in memory of a Past Grand First Principal which has been applied to the Release a Miracle Fund.

We note that the Public Relations Committee has been very active and has prepared and presented new promotional information including new pamphlets, a DVD and a Public Relations website.

We also noted that the Grand Lecturer has completed and edited the Manual of Etiquette and Protocol soon to be printed. In addition other Manuals have also been updated.

We are pleased to note that the Grand Representatives have been appointed near other recognized Grand Chapters and congratulate the Grand First Principal for selecting worthy Companions for these appointments.

The Grand First Principal has reported very favourably on the work of two Ad Hoc Committees; Computer Resources and Long Range Planning. He intends to continue both Committees and has appointed the Chairmen of those Committees to continue.

Under the title FUTURE GRAND CONVOCATION, the Grand First Principal reports that the 2012 and three subsequent Grand Convocations will be held in Woodstock at the Quality Inn and Convention Centre.

Your Committee recommends that the Actions and Recommendations of the Grand First Principal be approved by this Grand Convocation of Grand Chapter.

Chapters failing to comply with the foregoing Regulations, shall be deprived of the privilege of voting at the next annual Grand Chapter Convocation. The Grand First Principal may, at his discretion, summon the Chapter to show cause why its Warrant should not be suspended until such time as the Dues are paid and the Annual Returns submitted.

Write the names of Companions, in full, plainly in the Returns, so that there may be no errors in completing the Grand Chapter Certificate. Also see that the age, occupation and place of residence are not omitted. Where deaths are included, the date of death as well as the Companion's rank should accompany the record, also state if a Commuted Member.

Send a full list of the Officers of your Chapter **immediately after Installation**. Do not enter material on any form not requested. Use a separate sheet for other information you wish to convey to the Grand Scribe Ezra's office

MASONIC CALENDAR

Ancient Craft Masons: commence their era with the creation of the world, called it Anno Lucius (A.L.), "In the year of Light," and add 4000 to the common time, thus 2000 plus 4000 equals A.L. 6000. Lodges A.F. & A.M. hold Annual Communications

Royal Arch Masons: date from the year the second Temple was commenced by Zerubbabell, Anno Inventionis (A.I.), "In the year of Discovery," and add 530 to the common time, thus, 2000 plus 530 equals A.I. 2530. Royal Arch Chapters hold Annual Convocations.

The Order of High Priesthood: dates from the year of the blessing of Abraham by the High Priest Melchizedek, King of Salem, Anno Benedictionis (A.B.) "In the year of Blessing," and add 1913 to the common time thus, 2000 plus 1913 equals, A.B. 3913 Councils of the Anointed High Priests hold Conventions

Royal and Select Masters: dates from the year in which the Temple of Solomon was completed, Anno Depositionis (A.D.), "In the year of the Deposit," and adds 1,000 to the common time, thus, 2000 plus 1,000 equals A.D. 3000. Councils of Royal & Select Masters, hold Assemblies.

Knights Templar: commence their era with the organization of the Order, Anno Ordinis (A.O.), "In the year of the Order," and deduct 1,118 from the common time, thus, 2000 less 1,118 equals A.O. 882. Preceptories of Knight Templars hold Assemblies.

Scottish Rite: date same as Ancient Craft, except the use of the Jewish chronology, Anno Mundi (A.M.), "In the year of the World," and add 3,760 to the common time, thus, 2000 plus 3,760 equals A.M., 5760. After each September add another year, Consistories of Ancient & Accepted Scottish Rite hold Rendezvous or Reunions.
